

ETHO Tax Credit

STEP ONE - Make a donation to Community Care Network and complete application to reserve credits.

1. Make a donation to Community Care Network & receive donation receipt.

Give a life changing gift to Community Care Network. Donations can be made <u>online</u>, by mail, when visiting us in person, or contact us and we will come to you. You will receive a donation receipt for your records.

2. Complete an application to reserve your credits. There are two options:

A) Download a <u>paper copy</u> to return to us and we will complete the process for you. (Recommended)

OR

B) Complete the online application at the MS Department of Revenue website using the following guide:

a. Go to the MS Department of Revenue website at tap.dor.ms.gov or <u>click here</u>. Access the application by clicking "*Apply for a Charitable Contribution Credit*" link under the *Apply Online* box.



b. Select *"ETHO - Eligible Transitional Housing Organizations"* from the dropdown menu.

STEP THREE - Apply Tax Credits

In 7-10 days you will receive a receipt from the Department of Revenue with proof of your tax credits. Take this receipt to the local tax accessor's office to claim property tax credits or to your accountant for income tax purposes.

Always talk to your tax advisor before making any decisions regarding your tax liability. Please let your tax advisor know you are interested in taking advantage of the tax credit allowed by the Eligible Transitional Home Organizational Act 27-7-22.47 of the Mississippi Code Annotated.
